

BCA Transport Service (Transport process for buyers from Germany)





1. Vehicle Purchase

Buy your vehicle at one of our online auctions.



2. Payment of the vehicle invoice

You will then receive an invoice from us for your vehicle purchase.



3. Dispatch of the collection release by BCA

After receipt of payment we will send you the collection release.





4. Transport of your choice

Have your vehicle transported conveniently via BCA (enquiry via transport calculator), commission a haulier of your choice (collection release and collection authorisation are required for this) or simply collect your vehicle yourself.



5. Vehicles that cannot be driven or rolled

For vehicles that are not roadworthy, please send a cost request by e-mail to: transporte.outbound.de@bca.com



6. Document dispatch after receipt of payment







BCA Transport Service (Automatic transport for buyers in the EU (except Germany)





1. Transport costs

Use the transport calculator to find out about the transport costs for automatic transport before you buy a vehicle.*



2. Vehicle purchase

Buy your dream vehicle at one of our auctions.



3. Payment

You will receive a vehicle invoice including transport costs. After receipt of payment, you will receive an e-mail as confirmation of payment and the automatic transport will be initiated.





4. Automatic transport

If the delivery is to be made permanently to a different

delivery address, please complete the form "Confirmation of alternative delivery address" (Service/Download) and send it to us.



5. Vehicle documents

The vehicle documents will
be sent to you after you have sent us the CMR
and the confirmation of arrival to:

BCA Transport Service Self-organized transport for buyers within the EU (excluding Germany)



1. Certified Carrier

If organizing the transport yourself suits you better, you'll need to hire an independent certified carrier to pick up your purchase at the selling compounds.



2. Vehicle Purchase

Bid on a vehicle in our auctions.



Payment of the Vehicle Invoice and Providing Carrier Information

You will receive an invoice for your vehicle purchase from us. Please promptly provide us with your carrier's details if they are not already known to BCA.



4. Carrier Approval

Your carrier must be approved by BCA the first time and must be an independent third-party carrier with an international transport license, capable of providing CMRs for journey documentation.

To verify this, BCA needs to receive from you: A completed Carrier Notification Form.

The carrier's official transport insurance policy, valid at the proposed pickup date, ensuring that the transport company is insured for any damages to vehicles on BCA premises, and that your vehicle is insured during transport and delivery.

5. Carrier Verification and Pickup Notification

Upon receipt of your vehicle payment and carrier details, BCA will verify your chosen carrier for VAT compliance, which may take a few working days. Once the verification is complete, you will receive a pickup notification, and you will need to notify the selling compound of your arrival at least 48 hours in advance.



6. Vehicle Documents

Your vehicle documents will be sent to you after receiving the completed CMR.

Important Note:

If your purchased vehicle(s) are not picked up within 14 calendar days, transportation will be arranged by BCA, and you will receive the corresponding invoice. Once the transport payment is received, your vehicle will be transported to you.

3. Dispatch of the pick-up release

After receipt of payment we will send the collection release.





4. Transport

Commission a third party or carrier of your choice with the collection incl. the collection release or collect your vehicle yourself.



5. Vehicle documents

You will receive the vehicle documents when you collect the vehicle.



6. Tax

For vehicles that leave the EU
border, you will get the VAT back as soon as you
send us the customs documents (EUR1, EX1)
